Executive Summary Doris—Madrid (translated)



Executive Summary (English, Inuktitut, Inuinnaqtun)

TMAC Resources Inc. (“the Proponent”) has proposed the Madrid-Boston (Phase 2) Project (“the Project”) which focuses on mining of the Madrid North, Madrid South, and Boston deposits by utilizing and expanding upon the Doris Project infrastructure for the integrated development of the Hope Bay Belt. All associated surface infrastructure, water use and activities for the Madrid-Boston proposal are under a coordinated review process with the Nunavut Impact Review Board and the Nunavut Water Board. As such, the pre-hearing conference held to review the Draft Environmental Impact Statement and Type A Water licence application, determined that TMAC should submit two water licence applications with the Final Environmental Impact Statement for the Madrid-Boston proposal. The NWB determined that TMAC should submit a Type A Water Licence Amendment No. 2 application for 2AM-DOH1323 and a separate Type A application for the proposed project at Boston.

This application is for Amendment No. 2 of the existing Doris Amendment No.1 Type A Water Licence 2AM-DOH1323 and addresses water use, surface infrastructure and waste management associated with the mining, ore processing and tailings deposition of the Doris and Madrid ores. A portion of Boston ore will be processed at the Doris process plant and therefore is also captured under the scope of this application.

In addition to the infrastructure and activities listed in PART A of Amendment No. 1 of the Type A Water Licence 2AM-DOH1323, for Amendment No. 2 to this licence, TMAC requests:

- extend the life of all required activities and facilities of the already approved under Amendment No. 1 of the Type A Water Licence to the end of 2037, including the closure and post closure stages of the Madrid-Boston Project;
- to expand the scope of Type A Water Licence Amendment No. 1 2AM-DOH1323 to include the scope of all facilities and activities authorized under the existing Type B Licence 2BB-MAE1727;
- to allow for additional domestic and industrial water use from permitted and existing water sources at the south end of Windy Lake and Doris Lake, respectively;
- a second water source intake location from Windy Lake at a more proximal distance to the Doris site which will decrease transport distances;
- expansion of existing accommodation facility and sewage treatment plant at the Doris site to support approximately 400 people;
- construction and operation of an all-weather road extending from Madrid to Boston, stream crossings and additional quarries to be used along the all-weather road;
- complete development of the Madrid North and Madrid South underground workings to commercial scale. The existing Doris mine will continue as an underground mine and the Doris process plant will process a portion of the ore from the Madrid and Boston mines;
- expansion of surface infrastructure and facilities as required, including additional fuel storage, ore pads, waste rock pads, vent raises, additional power supply, a 1,200 tonnes per day concentrator at Madrid North, maintenance shops, warehouses and reagent storage;
- additional contact water ponds to capture surface water run-off. Water in contact water ponds may be used for processing or underground drilling, discharged to the Tailings Impoundment Area or discharged to the tundra if it meets criteria specified in the licence. Mine water will be pumped to the marine mixing box at Doris and discharged to Roberts Bay;

- a tailings pipeline, reclaim pipeline and all-weather access road from the Madrid North concentrator to the south end of the Doris Tailings Impoundment Area; and
- expansion of the Doris Tailings Impoundment Area to a capacity of 18 million tonnes by raising the south dam and constructing the west dam.

TMAC has a functioning environmental health and safety management system composed of numerous management plans which have been updated to address all management activities for the entire Hope Bay Belt and are included in this application to the Nunavut Water Board to support the proposed Madrid-Boston Project proposal.
