Re: Technical Comment Response Package for AANDC, EC, DFO, NRCan, GN & GNWT

Dear Amanda,

Sabina Gold & Silver Corp. (Sabina) is pleased to provide the attached Technical Comment (TC) Response Package for comments provided by the following submitting parties.

- Government of Canada including:
 - Aboriginal Affairs and Northern Development Canada (AANDC)
 - Environment Canada (EC)
 - o Fisheries and Oceans Canada (DFO)
 - o Natural Resources Canada (NRCan)
- Government of Nunavut (GN)
- Government of the Northwest Territories (GNWT)

Sabina's TC Response Package consists of a primary spreadsheet, expanded responses, and an appendix. The majority of responses are provided in the spreadsheet. Where individual responses required additional space these have been included, by submitting party, in expanded response files. An appendix is also included for those TC's which required larger reports or files.



Sabina has classified all responses to TC's as 'Yes', 'Partial', or 'No':

- Yes A Yes rating was assigned to TC's that Sabina agrees with; and/or provides the requested
 information in the TC Response Package or points to already available information; and/or
 Sabina agreeds to include the requested information in the FEIS or at some point in the future.
- Partially A Partial rating was assigned to TC's where Sabina agrees with a portion, but not all, of the TC.
- No A No rating was assigned to TC's for which Sabina disagrees with the TC.

In total 185 responses are provided in this package. Overall, Sabina has agreed to 71% of the TC's provided, with an additional 23% partially agreed to, and 5% not agreed to. A summary of responses, by submitting party, can be found below.

^{*} Note that the total number of TC's may appear larger than the number submitted by an individual submitting party. In certain cases Sabina choose to subdivide a single TC into multiple TC's when a submitting party made multiple comments or recommendations in one TC, and where those TC's were varied in topic or focus area.

The TC's varied in subject area and were generally in line with a submitting party's area of focus or mandate. In particular wildlife, hydrology and socio-economic concerns were identified. A summary of key subject areas can be found below.
