Re: Submissions to the Nunavut Impact Review Board regarding the Preliminary
Hearing Conference for the NIRB's Review of Sabina Gold & Silver Corporation's
Back River project

Dear Chiefs Felix Lockhart, Edward Sangris, and Ernest Betsina:

As you are aware, the Nunavut Impact Review Board (NIRB or Board) recently held a Community Roundtable and Pre-Hearing Conference (PHC) in Cambridge Bay from November 17-19, 2014 as part of its public Review of Sabina Gold & Silver Corporation's (Sabina) Back River project proposal (the Project) (NIRB File No. 12MN036).

The PHC allowed members of the public, Inuit organizations, and government agencies to discuss the Draft Environmental Impact Statement that was submitted to the NIRB by Sabina in

January 2014, and to identify any areas requiring additional analysis prior to moving forward with the final phase of the Board's environmental assessment process. The NIRB was pleased to facilitate the attendance of community representatives from Nunavut communities including Cambridge Bay, Gjoa Haven, Taloyoak, Kugaaruk, Kugluktuk, Bathurst Inlet and Bay Chimo, as well as the attendance of representatives from the Northwest Territories communities of Behchokò, Łutselk'e, Whatì and Wekweèti. Community representatives participated actively throughout the community roundtable and PHC, providing the Board with valuable comments and perspectives to consider for its assessment of the proposed project.

The Board acknowledges the submissions received on November 18, 2014 from the Yellowknives Dene First Nation (YKDFN) and on November 19, 2014 from the Lutsel K'e Dene First Nation (LKDFN) with regard to the PHC proceedings for the Back River project proposal. The NIRB is currently preparing its PHC Decision Report for the Review of the Back River project proposal, which will outline the progress made in this assessment to date while providing direction to the Proponent and parties regarding the key issues that must be further addressed through the pending Final Environmental Impact Statement submission and the Final Hearing that will subsequently follow; the NIRB will ensure that the input provided by both organizations is given due consideration while developing its PHC Decision Report. The NIRB anticipates releasing its PHC Decision Report prior to December 24, 2014 and will provide your offices with copy of the report once issued.
