### Dates of Final Hearing

As identified in the Board's correspondence of January 23, 2017, in response to the Responsible Minister's referral of the Back River Project back to the NIRB to further assess deficiencies with respect to five main ecosystemic issues, the Board has determined that a Public Hearing should be held to support the Board's further assessment of these issues. On this basis, the Board has determined that as with the previous Final Hearing, this Public Hearing will be held in the community of Cambridge Bay, and will involve a combination of technical and community sessions. Reflecting the Board's direction and availability of meeting venue and logistical support, the NIRB is pleased to announce the following schedule for the Public Hearing in support of this further Review:

\*NOTE: The NIRB may, in its discretion, extend any day session into an evening session if required.

While the agenda for the Public Hearing will be circulated to all parties in advance and may be adjusted as necessary at the discretion of the NIRB's Chairperson, the schedule for these proceedings has been arranged such that the first portion of the Public Hearing will consist of formal proceedings, including technical presentations, while the latter portion will allow for more directed community engagement through community roundtable sessions. An evening session will be held to ensure members of the community also have adequate opportunity to participate outside of regular working hours.

## Public Hearing Logistics & Details

The Public Hearing will be conducted in accordance with the NIRB's Rules of Procedure (the Rules)<sup>1</sup>. Proceedings will be facilitated by the NIRB's Board Members, with support from NIRB staff and legal counsel as required. A stenographer will be present at the Hearing to record an official transcript, and simultaneous English-Inuinnaqtun, English-Inuktitut, and English-T'licho interpretation will be provided through all proceedings, while French interpretation may also be provided if requested at least 14 days in advance of the Hearing. Access to the full public registry will be made available during proceedings.

# Intervenor Participation and Attendance

For the previous NIRB Final Hearing for the Back River Gold Mine project (April 25-30, 2016) the NIRB requested that parties wishing to apply for intervenor status at the proceedings identify themselves under Part III, Rule 22 of the NIRB's Rules of Procedure. For this Public Hearing, the NIRB is not requiring parties who participated as Intervenors in the previous Final Hearing to apply again for intervenor status. The Board encourages all previous Intervenors to continue with their participation and attend the upcoming Public Hearing. Intervenors are asked to confirm their participation and attendance at this Public Hearing by **April 18, 2017**.

### **Summary**

In closing, as we move closer to the Public Hearing for the NIRB's further Review of the Back River Gold Mine project proposal, the Board thanks all parties for their continued active engagement in the Board's processes. Additional details regarding the Hearing will be provided as they become available.

As a reminder to all parties, the NIRB requires parties that participated in the previous Final Hearing to confirm attendance at the upcoming Hearing by **April 18, 2017**.

The NIRB reminds all parties that the deadline for final written submissions is April 24, 2017.
