Hello Dave,

On November 14, 2018, the Nunavut Water Board (NWB) provided Sabina with Type A Water Licence 2AM-BRP1831 (Licence) approved by the Minister. Part E, Item 2 of the Licence requires Sabina submit a revised Water Management Plan (Plan) within sixty (60) days following approval of this Licence by the Minister:

The Licensee shall submit for Board Approval, within sixty (60) days following approval of this Licence by the Minster, a revised Water Management Plan. The updates are to take into account commitments made with respect to submissions received during the technical review of the Application, as well as final submissions and issues raised during the Public Hearing Process, where applicable an include at a minimum:

- a. updated Saline Water management Plan appendix; and
- b. further detail respecting potential management and treatment options related to water quality in the effluent discharge from flooded pits and the downstream receiving environment.

On December 13, 2018 Sabina provided notification of our intent to not enter full Construction due to financing. Due to this. Sabina is notifying the NWB that our submission related to the above will now be submitted with the additional Water Management and Monitoring related submissions (Part E, Item 15 and Part I, Item 2 of the Licence) to the NWB on March 31, 2019. This additional period will also allow Sabina to make any required updates to the Plan that are a direct result of submissions related to Part E, Item 15 and Part I, Item 2.

Should Sabina not make a Construction decision by March 31st, 2019, additional information will be provided by Sabina to the NWB in advance of this date.
