

Hallo John,

I've also completed the review of the WIR and I have no comments/concerns. I did check the satellite images (similar to last year) and while once can clearly see the on-land sections of the WIR I didn't note changes from last year's observations that would indicate erosion. I also had a quick look at the seasonal forecast provided by ECCC (Nov – Jan (left) and Dec – Feb (right)), and it looks as if this year's winter may not be as warm, i.e. likely providing decent conditions for the construction and operation of the WIR. These are seasonal forecasts, which always have high uncertainty, but it is a trend.
