In earlier discussions with Sabina this March, they requested to submit a final hydrodynamic model (HDM), including mixing zone design, and the updated water and load balance model (WLBM), including additional groundwater modelling and water quality modelling, to the Board by August 30, 2022.

Taking into account this timeline, I think **Option 1** would be the most logical, because by the time Sabina has the HDM and WLBM ready, they will also have the comments from all Parties and will be able to provide a combined response, which will include the answers to the Parties' questions, as well as the updated HDM and WLBM.

Good Afternoon,

I spoke with our Water Quality Experts, and they provided me a couple of potential timelines that would be preferable, as the updated Water and Load Balance document is listed as “pending submission in August 2022”:

Option 1: If the Water and Load Balance document will be sent out to ECCC for review anyhow, ECCC could provide comments on the 2021 Annual Report on the current review timeline (due date July 28, 2022), with exception of the Water Management Plan. We would then provide the Water Management Plan comments with the review of the Water and Load Balance document.

Option 2: ECCC would require an additional 10 business days for review of the 2021 Annual Report from the date we receive the Water and Load Balance document.

Would either of those be preferable?
