## **Project Changes:**

Item #5: Appendix B bathymetry map and aerial photo - Looks like these were inadvertently left out of the June 25th submission. Both are attached to this email. We will bring 50 copies of each with us to the hearing.

#### Committments:

Item #5 - Drawing of Tailings Pipeline across Doris Creek - Similarly this got left out. The drawing is attached to this email. We will bring 50 copies with us to the hearing.

Item 14 - Field pH readings of standing water on tundra. - We do not have a map or sketch showing these sample locations. The samples were collected by Golder Associates on our behalf on June 22nd and 23rd at the locations as cited in the Table provided in the June 25th submission. In looking at Item #14 in Sheet 2 of the NWB Technical Hearing Table there is no reference to a drawing. If this is something you need I would have to go back to Golder and request that they prepare one. I doubt this could be completed before the hearing.

Item #29 and 40 - Field selection of the proposed location of the Tail Lake discharge (updated drawing) and of the proposed SNP point below the waterfall. Nathan Schmidtt (Water Resource Engineer with Golder Associates) and Maritz Rykarrt (Geotechnical Engineer with SRK) went to site together in mid July to inspect both locations, collect stream cross sectional information and select a proposed final locations for both point. They are preparing a report on this work but due to vacations and other committments it has taken longer than expected. They are supposed to provide us a draft copy tomorrow. We will endeavour to get this finalized and to bring 50 copies to Cambridge Bay with us for submission to the NWB on Monday. In the meantime we did include a series of photographs in the June 25th submission (under Item #29 and Item 40) that show the top and bottom of the waterfall. I also reference SRK Drawing T-11 Tailings Slurry, Reclaim, Fresh Water Make-Up and Decant Pipelines in Supporting Document S4 to the April 2007 which shows the alignment of the 14" HDPE Decant (Discharge) pipeline. Maritz and Nathan conducted a visual inspection to site the discharge end of the pipe on a portion of the creek where bedrock is dominant.

Can you please publish this email to the NWB ftp site and to the Doris North distribution list so that everyone has access to this information.
