Executive Summary Application for Amendment No. 2 of Water Licence No. 2AMDOH0713 Request to change original proposed location of Explosives Mixing and Storage Facility

In this application, Hope Bay Mining Ltd. ("HBML") is requesting that the Nunavut Water Board ("NWB") amend Water Licence No. 2AM-DOH0713 to permit HBML to change the original proposed location of its Explosives Mixing and Storage Facility (the "Explosives Facility"). The Explosives Facility has not yet been constructed. The Explosives Facility was originally intended to be located north-west of the Doris camp site, a safe distance west of the primary access road. This facility will instead be installed at the Secondary access road close to the proposed South Dam at Tail Lake. The Explosives Facility will be within the Commercial Lease boundary and the KIA has indicated it will permit the change. Drainage from the new location will continue to flow towards Tail Lake, as anticipated with respect to the Tail Lake road and other infrastructure remaining in the proposed location

This change will not expand or alter the purpose or the function of the Explosives Facility. The change will trigger minor revisions to maps included in the Spill Contingency Plan which will be amended to reflect the new site layout.

Accordingly, HBML requests the NWB revise the definition of Explosives Mixing and Storage Facility provided under Water Licence 2AM-DOH0713 Schedule A – Definitions, which currently states:

"Explosives Mixing and Storage Facility" means a facility designed for the storage of ammonium nitrate, detonators and explosives; and designed for the mixing and storage of Ammonium Nitrate Fuel Oil (ANFO), as illustrated in the Revised Water Licence Application Supporting Document S4 entitled "Engineering Drawings for Tailings Containment Area and Surface Infrastructure Components", DWG. S-04 dated Mar 2007, SRK Job Number ICM014.008;

To read as follows:

"Explosives Mixing and Storage Facility" means a facility designed for the storage of ammonium nitrate, detonators and explosives; and designed for the mixing and storage of Ammonium Nitrate Fuel Oil (ANFO), as generally illustrated in Engineering Drawings for the Doris North Explosives Facility, Doris North Project, Nunavut, Canada DWG TL-EXP-01 and as may be revised from time to time;
