***Re: Revisions to TMAC Resources Inc. Amendment Application No. 1 of Project Certificate 003 and Water Licence 2AM-DOH1323 – Application Deficiencies***

---

TMAC wishes to respond to the letter from the NWB received on July 3, 2015, to address the deficiencies in the application package, as identified by the Nunavut Water Board (NWB). Note that inconsistencies, as identified by the NWB, relating to waste rock and ore management planning have been addressed under a separate cover (TMAC letter to The NWB dated July 6, 2015).

The deficiencies are understood to be:

- "Figures 3 and 4 of the Project Summary are missing;
- The Supplemental Information Guideline (SIG) is incomplete. Block No. 61 of the NWB's SIG should address comments of AANDC's Inspector in the 2014 Inspection Reports;
- The Reclamation Security information is incomplete. The Reclamation Security states that the new 2015 estimate of closure costs is \$25.1 million, representing an increase in closure liabilities of \$3.6 million; TMAC should provide details (i.e., spreadsheet based) of the estimation."

**Project Summary Figures 3 and 4**

We have confirmed that, while Figures 3 and 4 were included in the electronic submission to the NWB, it is expected that there may have been transmission errors associated with the volume of emails and attachments sent, comprising the application. Accordingly, these figures are included herein, for your reference.

## **SIG Block No. 61**

Content fulfilling the information requirement for this Item was omitted from the submission in error, and is appended herein, including:

- A summary of 2014 Inspections (2; AANDC) and actions taken, as provided to the NWB in the annual report for 2AM-DOH1323;
- A summary of 2014 Spills (3) and actions taken, as provided to the NWB in the annual report for 2AM-DOH1323;
- A map illustrating the location of the spills.

Note that, at the time of submission, no AANDC Inspections have taken place nor have any spills or accidental releases occurred in 2015.

### **Closure Cost Estimation Details**

The details supporting the closure cost estimate, including spreadsheets, are provided in the attached document, *Doris North Mine Interim Closure and Reclamation Plan, July 2015 – Detailed Cost Estimate* (July 2015). This document should be read in conjunction with *Doris North Mine Interim Closure and Reclamation Plan* (June 2015; P5-2) and *Costing Assumptions Summary for Doris North Mine Interim Closure and Reclamation Plan* (June 2015; P6-5), already submitted to the NWB with the Application package.

Upon receipt and review of these documents, it is understood that the Application can be distributed to interested parties.
