Ryan, Li, Dionne, and Phyllis,

Chris Hanks asked me to give you an update on the status of HBML's Doris North Mine Changes and Related Amendments Application.

The package is nearly complete and is currently under review by KIA and its suite of consultants (KIA has asked HBML to undertake this preliminary step before formal submission to regulatory authorities). Once KIA have completed their preliminary review, HBML plans to formally submit to NIRB and NWB the detailed description of the changes, supporting technical memos which consider these changes (including detailed environmental reports from Rescan, geochemical analysis and engineering briefs from SRK and other engineering consultants, and an updated project water balance), as well as a summary of the changes to the Project Certificate and Type A Water Licence that HBML has identified as necessary to proceed with the proposed Mine changes.

Provided KIA review completes in the agreed time period, HBML anticipates submission to NIRB and NWB in the first week of November. HBML would like to proceed with some of the changes contemplated in the application as early as Q1 2013.

To that end HBML would like to schedule a meeting with NIRB and NWB once you have had opportunity to review the application package to identify any additional information requirements and also to get a sense of the anticipated regulatory schedule for processing the amendments. HBML proposes to have this meeting at the end of November and would be pleased to travel to both Cambridge Bay and Gjoa Haven if it would assist.
