**Location of Hearing:** The Public Hearing will be conducted in writing **Date and Time:** The Public Hearing will commence on July 12, 2013.

Directions on the procedure for the conduct of the written Public Hearing will be issued by the NWB following a Pre-Hearing Conference. Interested persons are required to inform the NWB, Manager of Licensing at the contact information set out above, by July 2, 2013, of the intention to make representations at the Public Hearing.

The NWB may decide not to hold the Public Hearing if the Licensee consents in writing to the disposition of the application without the Public Hearing, provided that no other person informs the NWB by the tenth day before the day of the Public Hearing of the person's intention to make representation.
