Sonia, in response to the NWB's request, I can confirm that as this application was being assessed by the NIRB under the Nunavut Land Claims Agreement before July 9th, it is exempt from NUPPAA under section 235(1)(a). As such, it does not need to be submitted to the NPC for review. The correspondence from 2010 stating that it is in an area without an approved land use plan still applies, and a conformity determination is not required.
