Re: Request for Change of Name and Deferral of Doris North Project

Dear Mr. Hanks:

The Nunavut Impact Review Board (NIRB) acknowledges receipt of Hope Bay Mining Ltd.'s (HBML) letter dated September 11, 2008, advising the NIRB that HBML has indefinitely deferred the Doris North Project as a stand-alone project in order to pursue a broader belt-wide strategy that will incorporate the Doris North deposit. Followings meeting with NIRB staff on March 17, 2009, and April 3, 2009 to clarify issues related to September 11, 2008, letter, NIRB further acknowledges receipt of a letter dated April 20, 2009, requesting a change of name for the Doris North Project Certificate # 003 (PC) and providing an update to NIRB related to HBML's project development and status of HBML's compliance with requirements of the PC.

The Nunavut Water Board (NWB) also advised the NIRB that on January 13, 2009, HMBL provided notice pursuant to Part L, Item 2 of Doris North Type A Water Licence 2AM-DOH0713 (Water Licence) of the intent to enter into a care and maintenance phase. Supplemental information was provided to the NWB on April 21, 2009. At this time the NIRB is requesting comments from the parties on: 1) the request for a name change to the NIRB PC, and 2) whether the indefinite deferral of the Doris North Project as a stand-alone project in order to pursue a broader belt-wide strategy creates any issues of non-compliance with the PC. The NIRB notes that any future decisions to pursue a broader strategy will require impact assessment pursuant to Article 12 of the Nunavut Land Claims Agreement.

The NIRB notes that under separate cover, the NWB is requesting comments from the Parties on HBML's proposed approach to deferring certain terms and conditions of the Water Licence pursuant to the notice of care and maintenance without an amendment to the Water Licence. The NWB is further seeking comments on the specific provisions of the Water Licence proposed to be deferred, and any other issues identified by the Parties. The NIRB brings this to the attention of the parties to facilitate concurrent reviews where appropriate.
