**Re: NIRB's Information Sessions for the Reconsideration of TMAC Resources Inc.'s Project Certificate No.: 003 for the Doris North Gold Mine project**

Dear Catharine Farrow:

On December 9, 2013 the Nunavut Impact Review Board (NIRB or Board) received an application from TMAC Resources Inc. (TMAC or the Proponent) which outlined proposed modifications to the Doris North Project, including amendments to both the NIRB Project Certificate (Project Certificate) and the Nunavut Water Board (NWB) Type A Water Licence (NWB File No. 2AM-DOH0713) (known collectively as the "amendment application"). As communicated in previous correspondence, the NIRB has determined that a reconsideration of the terms and conditions contained within the Doris North Project Certificate pursuant to section 12.8.2 of the Nunavut Land Claims Agreement (NLCA) will be necessary in order to properly consider the proposed modifications to the Doris North Project.

As part of the reconsideration, the NIRB will be holding open house meetings and community information sessions in the Kitikmeot communities as follows:

NIRB staff will host an afternoon open house in each community, and will facilitate evening information sessions to discuss the following:

- Explain the NIRB's process to reconsider terms and conditions within the Project Certificate;
- Provide an overview of the proposed modifications to the Doris North project; and
- Explain how members of the public may participate in the next steps of the NIRB's process to reconsider the terms and conditions within the Doris North Project Certificate.

The NIRB looks forward to visiting each of the Kitikmeot communities as outlined above, and to hearing any questions or comments that may be raised by interested members of the public during these sessions.
