On August 21, 2015 the Nunavut Impact Review Board (NIRB or Board) accepted TMAC Resources Inc.'s (TMAC) 2015 amendment application for the Doris North Project Certificate No. 003 (05MN047) and commenced the technical review by requesting all interested parties submit their Information Requests (IR) to the NIRB by September 11, 2015.

The NIRB received the attached request on August 25, 2015 from Aboriginal Affairs and Northern Development Canada (AANDC) to extend the commenting period by 5 business days to allow for review of the documentation provided.
