Please see the attached correspondence from the Nunavut Impact Review Board (NIRB or Board) regarding the Board's reconsideration of TMAC Resources Inc.'s (TMAC) Doris North Project Certificate No. 003 (NIRB File No. 05MN047). On November 4, 2015 the NIRB and the NWB provided confirmation that TMAC's Amendment Proposal and subsequent submissions both complied with the NIRB requirements and had been determined to be a complete water licence application by the Nunavut Water Board (NWB), and as a result the NIRB and the NWB commenced a coordinated public technical review period.
