In accordance with the Doris Gold Mine Project Certificate No. 003 (the Project Certificate) originally issued by the Nunavut Impact Review Board (NIRB or Board) on September 15, 2006 and amended on September 23, 2016, the Board has prepared the enclosed draft revised *Appendix D – Doris North Gold Mine Monitoring Program*.

The draft revised *Appendix D* has been designed to be consistent with the project monitoring framework previously established by the NIRB for the Doris North Gold Mine Project and other mine development projects in the Nunavut Settlement Area. The purpose of this document is to provide clarity and guidance with respect to the NIRB's expectations for project monitoring and reporting by TMAC Resources Inc. (TMAC), Government, and the Board's Monitoring Officer for the Doris North Gold Mine project.

By copy of this letter, the NIRB invites parties to review the draft revised *Appendix D* and provide any comments or concerns regarding this draft document directly to the NIRB. Interested parties are asked to provide comments relating to their area of expertise and/or mandated responsibilities, or any other matter of interest as may relate to the Doris North Gold Mine project and the proposed monitoring program as outlined in revised *Appendix D*.

Comments can be submitted to the NIRB on or before **October 11, 2017**. Following the receipt of public comments, it is the Board's intention to issue the final version of revised *Appendix D* to TMAC.
