On September 20, 2022, the Nunavut Water Board (NWB or Board) acknowledged the receipt of the updated Hope Bay Quarry Management Plan (Plan) from Agnico Eagle Mines Limited (Agnico Eagle or Licensee) and sent it out for comments until October 6, 2022.

It should be noted that this Plan was originally revised in March 2022 and subsequently reviewed. According to Agnico Eagle, the reason for this September 2022 updated version was to correct an editorial oversight where Quarry E was not included in the list of approved Hope Bay quarries.

Responses were received from Crown-Indigenous Relations and Northern Affairs Canada (CIRNA), Environment and Climate Change Canada (ECCC) and Kitikmeot Inuit Association (KIA) on or before the deadline of October 6, 2022, stating that they had no comments or concerns related to this Plan at this time.
