The KIA has reviewed TMAC's responses to the issues KIA has raised in our review of the 2019 Hope Bay annual report. All our issues have been adequately addressed through the provision of additional information, directing us to relevant documents, and by making commitments for the 2020 monitoring year.

However, TMAC should try to provide reference data along with measured toxicity data when presenting LC50 tests to make it is easier to access. Having to dig through the appendix to another appendix to find the values that are being

compared to is onerous, and it would be much more user friendly if TMAC reported the reference values next to the text values.

TMAC is committed to the use of an Arctic species in future LC50 tests, rather than relying on rainbow trout. KIA will only be able to evaluate the effectiveness of this change once LC50 tests have shifted to a more appropriate test species. The KIA has made a record of TMAC's comment to see what will be done with this issue in the next annual report.

The KIA has no further issues to raise with the 2019 Hope Bay Annual Report to the NWB at this time.
