Re. Evidence of Security under Part C, Item 1(b) of Type A Water Licence 2AM-DOH1323

Dear Mr. Kharatyan:

On December 16, 2016, the Minister of Indigenous Affairs and Northern Development Canada approved the amended Type A Water Licence 2AM-DOH1323 (the Water Licence) concerning TMAC Resources Inc. ("TMAC")'s Doris North Gold Project. As such, TMAC is pleased to jointly provide this letter which summarizes the current security which has been furnished and maintained by TMAC with INAC and with the Kitikmeot Inuit Association ("KIA") in respect of the Doris North Gold Project.

With respect to Part C, Item 1(a) of the Water Licence, as the Nunavut Water Board (Board) is aware, TMAC has previously furnished and maintained with INAC Letter of Credit LC SBGT758771 in the amount of \$13,090,000.

With respect to Part C, Item 1(b) of the Water Licence, TMAC confirm that pursuant to the Commercial Lease in respect of Inuit Owned Lands (IOL) held by the KIA, TMAC has provided KIA with the following letters of credit totaling \$17,635,650:

- Letter of Credit LC SBGT758737 (\$400,000);
- Letter of Credit LC SBGT758776 (\$1,366,000); and
- Letter of Credit LC SBGT761083 (\$15,869,650).

Copies of each of these letters of credit are enclosed with this correspondence. As determined by the Board in its Reasons for Decision dated November 4, 2016, the security held by KIA is held for the purposes of reclamation consistent with s. 76(2)(b) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* and is applicable to reclamation of the Mining Undertaking described in the Water Licence.

With respect to Part C, Item 2 of the Water Licence, the total security furnished and maintained by TMAC with INAC and KIA under Part C, Items 1(a) and 1(b) in the form of letters of credit totals \$30,725,650 as prescribed.

TMAC trust that with this letter and its enclosures, TMAC has fulfilled the requirements of Part C, Item 1(b) of the Water Licence. Should the Board require any further information with respect to this submission, please do not hesitate to contact John Roberts of TMAC.
