	I am following up to summarize our call earlier today.
	We understand that your discussion to come up with the updated security amount of \$72,907,727 involved CIRNAC, and did not include the Kitikmeot Inuit Association (KIA). The NWB would like Agnico Eagle to have a discussion with KIA and confirm their agreement with the updated security amounts.
	Once all parties are in agreement, we request that Agnico Eagle submit a revised table for Part C, Items 1 & 2, with the updated security amounts held under the Licence 2AM-DOH1335, and the schedule and specific stages of infrastructure construction.
	Upon receiving this update, the NWB will initiate the process to amend the security for the Licence 2AM-DOH1335.
