Here are KIA's responses to some of our technical comments.

KIA-8 (Surface waste rock stockpile):

 Agnico Eagle will submit detailed design of new waste rock stockpile to NWB at least 60 days prior to commencement of construction, as per Water Licence Part D Items 1 & 2.

Response: We thank Agnico Eagle for their response. We would encourage Agnico Eagle to provide some rationale for their statement that the new surface waste rock stockpile will not result in any environmental impacts prior to submitting their detailed design plan to the NWB. However, we accept this response for the time being.

KIA-9 (TIA water quality and non-compliance waters):

Agnico says there will be no changes to the environment site personnel or management – presumably no reduced site presence.

Response: We thank Agnico Eagle for their response and clarification. We still encourage Agnico Eagle to provide more information on the TIA's capacity to store non-compliant water (and time frames), which has not been addressed in their response.

KIA-10 (Additional WWTP installation):

 WTP is anticipated to be commissioned by Freshet 2023. Additionally, WTP support may be needed and will be assessed as part of Agnico Eagle Mines Limited Operational Readiness Plan.

Response: We thank Agnico Eagle for their clarification and consider the issue resolved for now.

All other AEM responses on the Care and Maintenance are acceptable to KIA.
