Re: 2AM-DOH0713 Notification of Effluent Discharge from Containment Areas for Plant Site Fuel Storage Facility ST-5

Please be advised that HBML, under Part G: Item 22 (e) and (f) of the Doris North Mining and Milling Type "A" Water Licence, is providing written notice to the Inspector prior to a planned discharge of accumulated snow melt water from the Plant Site Fuel Storage Facility ST-5 containment area at Doris Camp.

Samples collected at Monitoring Program Station ST-5 on May 26, 2011 were compliant with the effluent quality standards for discharge as specified in the licence (Table 1).

Water will be discharged on the tundra at north-west of the containment berm at approximately 13W 0432905 / 7559236 in a manner that prevents erosion at the point of discharge or downstream. The estimated volume for discharge is $160m^3$ from ST-5. The actual volume of water removed from the berm will be recorded for regulatory reporting purposes.
