Based on the analysis from the water sampling, AANDC approves the discharge of the sedimentation pond (ST-1). Water quality must meet the licence criteria, therefore samples should be taken daily to confirm this. If for some reason the water quality deteriorates below licence criteria, then water discharges will have to stop, and further treatment will be required.
