

## C. RESULTS OF REVIEW

# 2. Topic/Subject/Title

#### Comment:

Agnico Eagle's submission of the Non-Hazardous Waste Management Plans contains Table 4.1 that details the waste materials to be covered by the Plan, the Handling methods to be employed on the ground by staff, the storage or interim storage location before final disposition and then the appropriate disposal method as proposed.

In a number of cases there are options provided that include either the opportunity to dispose of a waste in the non-hazardous Land fill on site or the waste may be transported off site to a licensed disposal facility.

CIRNAC is concerned that the criteria for choosing either option is not defined in the matrix and therefore it is open to interpretation and/or misunderstanding by staff on site leading issues during inspection or remediation of the site.

## **Recommendation:**

(R-02) CIRNAC recommends that Agnico Eagle provide justification for when items will be placed in the non-hazardous land fill and the methodology to be used when determining what items will be transported off site to a licensed facility.

#### Agnico's Reply to Recommendation:

Only non-salvageable waste will be placed in the landfill. Landfills on site are a normal approved facility for construction, operations and closure.

### **CIRNAC's Response to Reply:**

Restates the recommendation and further, for clarity, Non-Salvageable waste is not a defined term. CIRNAC simply seeks clarity of process and would ask that be provided.

CIRNAC has no additional recommendations to the board.
