The proposals have been reviewed to determine whether they are likely to result in impacts to fish and fish habitat which are prohibited by the habitat protection provisions of the *Fisheries Act* or those prohibitions of the *Species at Risk Act* that apply to aquatic species.\*

Our review consisted of:

- Portal Modification Package sent to the Nunavut Water Board prepared by Hope Bay Mining Limited, dated February 24, 2010.
- Cover letter, Executive Summary and Application for Amendment No.2 of Water License No. 2AM-DOH0713 (Explosives Mixing and Storage Facility Relocation), dated May 20, 2010.

Provided that the plans are implemented as described, DFO has concluded that the proposals are not likely to result in impacts to fish and fish habitat.
