This e-mail is our response to you request of December 19, 2008.

Page 16: "The well being of residents of Canada outside the Nunavut Settlement Area must be taken into account", trans-boundary issues must involve reporting of discussion with Wildlife Management Boards for all Caribou herds in Canada as well as users and stake holders.

Page 17: 2.3 Sustainable Development 3) "The Precautionary Principle..." the explanation should be expanded to include the definition as per the "Canadian Government Perspective".

Page 34:6.7.1 Project Alternatives should examine the feasibility of a port facility on the Arctic Coast i.e. Grey's Bay, and the continued use of a winter road from Yellowknife.

Page 59: 6.16.2.9 Cumulative Effects: The proponent should identify historic and current exploration and development projects what measures have been taken to clean up those projects and the success of those efforts in the LSA and RSA.
