**Re: Landfarm Management Plan Amendments**

Dear Greg,

Based on information provided by Don Hayley of EBA on 28 October 2004 regarding the latest operational adjustments at the landfarm at Ekati Diamond Mine™, the following is an amendment to the Landfarm Management Plan submitted in support of the Jericho Project water licence application to Nunavut Water Board August 2004. Amendments are shown in red.

**Table 4-1: Petroleum-Contaminated Materials Classification**

Material	Destination
Light hydrocarbon contaminated soil < 4 cm	Landfarm
Heavy hydrocarbon contaminated soil < 4 cm	Segregated – landfarm <sup>1</sup>
Rock > 4 cm	Remove majority of petroleum; store in a segregated area of the waste rock dump 2
Hydrocarbon contaminated snow and ice	Segregated in a lined area of waste rock dump 2 <sup>2</sup>

<sup>1</sup> Small volumes backhaul to Yellowknife to licensed contractor for disposal; large volume management to be determined

<sup>2</sup> All water in the lined area skimmed to remove floating hydrocarbons; sludge stored with waste oil and water transported to the PKCA.

#### **4.7 Contaminated Snow and Ice**

Contaminated snow and ice will be scraped up and placed in a dedicated lined area of waste rock dump 2. When liquid, water will be skimmed to remove hydrocarbon and the water transported to the PKCA for disposal. Skimmed oil will be placed in waste oil containers for return to Yellowknife to a licensed contractor on winter backhauls.

Prevention of birds entering the ponded water in the treatment area will be as discussed in the landfarm management plan, Section 4.5.6.
