Subject: Previous Work Carried Out by Hatch for Nunavut Water Board

Further to your request by e-mail dated May 9, 2007 regarding our previous work for Nunavut Water Board (NWB), the following is our list of work completed for the NWB for the 2006-2007 contract period:

1. Participation in Meetings with Tahera Diamond Corporation (TDC) (our project No. H-323972).

We attended two meetings at the EBA office in Edmonton in late September and early November 2006. The meetings were intended to clarify the construction activities which TDC had carried out in previous and current year, and to keep update on the progress at the site. The meetings were attended by NWB staff, TDC, TDC's technical consultants (AMEC, EBA), and independent consultants to NWB (including Hatch Acres).
