Subject: Assignment of License 2AM-JER0410 (Previously NWB1JER0410)

The Nunavut Water Board (NWB or Board) received a request from Benachee Resources Inc. (Assignor) to assign Type A Water Licence 2AM-JER0410 (Licence) to a new entity also named Benachee Resources Inc, formerly known as Newco (Assignee).

The assignment is subject to applicable provisions of Section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*. Accordingly, the NWB is required to give public notice of the assignments before approving it.

The Nunavut Water Board is accepting written concerns and comments with regard to these assignments until July 20, 2009. By copy of this letter, the Board also requests that the Kitikmeot Inuit Association confirm in writing to the Board by no later than July 20, 2009, that there are no outstanding matters of compensation pursuant to the Licence. The Board further requests that Indian and Northern Affairs Canada (INAC) confirm in writing to the Board that the proposed Assignee has made arrangements to transfer the security obligations pursuant to the Licence to the Assignee prior to the assignment taking effect.
