## <u>Subject</u>: Fisheries Act Authorization Amendment #1 - Jericho Diamond Mine

In reviewing the need for an amendment to the subsection 35(2) Fisheries Act Authorization, the proposed changes to the original project were reviewed relative to the original screening that was conducted pursuant to subsection 18(1) of the Canadian Environmental Assessment Act (CEAA). In the context of the initial screening that was conducted under CEAA it has been determined that the proposed changes do not represent a significant change in the project.

The valid authorization period will be changed from December 31, 2007 to August 15, 2008.

The following conditions in Authorization Number NU-00-0068 shall be changed to read:

- 6.4.4 Implementation of the approved drawings for the construction of the rock shoals shall be completed prior to May 31, 2008.
- 6.5.4. Final detailed design drawings for the connecting channel (Stream 021) shall be submitted to Fisherles and Oceans Canada ~ Iqaluit Office on or before January 1, 2008 for review and approval.
- 6.5.5. Implementation of the approved drawings for the connecting channel (Stream 021) shall be completed prior to August 15, 2008.
- 6.6 All fish habitat compensatory works shall be completed prior to August 15, 2008.
  - 8.2.1. Monitoring of the Causeway shall be reported at the end of Year 3, 4, 5, 7, 9 and one (1) years following causeway reclamation (where Year 1 = 2005), and shall report on the sediment deposition adjacent to the structure.
  - 8.2.2. Monitoring of the Stream C1 Diversion Channel shall be reported at the end of Year 4, 5, 7, 9, 11 and 13 (where Year 1=2005), and shall include stream discharge and temperature (correlated with ambient air temperature).
  - 8.2.3. Monitoring of the rock shoals shall be reported at the end of Year 4, 5, 7, 9, 11 and 13 (where Year 1=2005), as outlined in the Detailed Compensation Monitoring Plan for rock shoals.

8.2.4. Monitoring of the connecting channel (Stream 021) shall be reported at the end of Year 4, 5, 7, 9, 11 and 13 (where Year 1=2005) as outlined in the Detailed Compensation Monitoring Plan for the connecting channel (Stream 021).

Similarly the proposed changes do not affect the decision made in the original screening report pursuant to subsection 20 (1) of CEAA. We have confirmed with the Nunavut Impact Review Board (NIRB) that this minor variation to the scheduling of monitoring requirements will not require a re-screening by the NIRB,

Therefore, the original Authorization for the harmful alteration, disruption or destruction of fish habitat arising from the Jericho Diamond Mine, issued April 15, 2005, is hereby amended according to the conditions outlined above.

All other conditions specified in the subsection 35(2) *Fisherles Act* Authorization issued April 15, 2005 remain unchanged. For your convience, I have also attached Table 1 outlining the revised schedule of due dates for mitigation and compensation monitoring reports.
