Further to the Technical Meeting and Pre Hearing Conference (TM/PHC) held in Cambridge Bay on June 20-22, 2011, the Nunavut Water Board (NWB or Board) requested that Shear Diamonds (Nunavut) Corp.'s ("Shear" or "Proponent") responses to the comments of interested parties and the List of Commitments completed and accepted during the PHC be reviewed by all parties, including those parties who were not in attendance at the TM/PHC, to confirm by June 29, 2011.

The Board received comments regarding the above mentioned Shear's responses and the List of Commitments from the Aboriginal Affairs and Northern Development Canada (AANDC), Environment Canada (EC) and Department of Fisheries and Oceans Canada (DFO)¹.
