Re: Pending Expiration Dates for Jericho Water Licence Security

Under the Nunavut Water Board assignment of the water licence NWB1JER0410 for the Jericho Diamond project, Benachee Resources Incorporated, a wholly-owned subsidiary of Tahera Diamond Corporation, is required to maintain a security with the Receiver General of Canada. The total security requirement is to ensure the project will be abandoned and reclaimed without liability to the people of Nunavut and Canada.

Although the Nunavut Water Board determines the amount of the security under the water licence, the Minister of the Department of Indian Affairs and Northern Development (INAC) determines the type of security instruments that are acceptable and the Nunavut Regional Office of INAC holds the securities.

Some of your security instruments will soon expire and we require confirmation of automatic renewal. The Securities known to the Nunavut Regional Office of Department of Indian Affairs and Northern Development are:

Irrevocable Letter of Credit Number #1020-9383975-17 dated February 25, 2005 from the Toronto Dominion Bank for Tahera Diamond Corporation with the beneficiary as the Receiver General for Canada for the Department of Indian Affairs and Northern Development for an amount of \$2,200,000.00 (Canadian Dollars- Two million two hundred thousand only) under water licence NWB1JER0410. A June 16, 2005 amendment verified the beneficiary and initial expiration date of February 24, 2006.
