Subject: Application by Shear Diamonds (Nunavut) Corp. (a wholly owned subsidiary

of Shear Minerals Ltd.) Seeking Assignment of Type A Water Licence 2AM-JER0410 from Benachee Resources Inc. to Shear Diamonds (Nunavut) Corp. (a wholly owned subsidiary of Shear Minerals Ltd.) and Seeking A Sixty (60)

Day Renewal of Licence 2AM-JER0410

Dear Minister:

This letter is a request by the Nunavut Water Board (NWB or Board), seeking your acknowledgement of the NWB's authorization of the assignment of existing water licence 2AM-JER0410 pursuant to s. 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* (NWNSRTA)¹, from Benachee Resources Inc. to Shear Diamonds (Nunavut) Corp. (a wholly owned subsidiary of Shear Minerals Ltd.) (Shear). In addition, the NWB requests that you consent to the NWB's exercise of its jurisdiction under s. 174(1)(a)(iii) of the NWNSRTA², exempting the application for a short-term renewal from the requirement to hold a public hearing, and that you consider for approval, as required under s. 56 of the NWNSRTA³, the short-term renewal of licence 2AM-JER0410, with no changes to the conditions of that licence, for a period of sixty (60) days (commencing on January 1, 2011).

¹ Section 44(1) of the NWNSRTA states that: 44. (1) A sale or other disposition by a licensee of any right, title or interest in an appurtenant undertaking constitutes, subject to the authorization of the Board, an assignment of the licence to the person to whom the sale or other disposition is made. (2) The Board shall, on application, authorize the assignment of a licence if it is satisfied that the assignment and the operation of the appurtenant undertaking would not be likely to result in a contravention of any condition of the licence or any provision of this Part or the regulations. (3) Except as provided in this section, a licence is not assignable.

² Subsection 174(1)(a)(iii) of the NWNSRTA states that the following class of application in respect of a Type A licence is exempted from the requirement of a public hearing: (iii) one or several renewals of a total duration not exceeding sixty days.

³ Section 56(1) of the NWNSRTA requires that: The issuance, amendment, renewal and cancellation of a type A licence and, if a public hearing is held, a type B licence, are subject to the approval of the Minister.

Background and Regulatory History:

On December 21, 2004, the NWB issued licence NWB1JER0410 (the Original Licence), authorizing Benachee Resources Inc. a wholly-owned subsidiary of Tahera Diamond Corporation, (Licensee) to use water and dispose of waste into water at the Jericho Diamond Mine site. The Jericho Diamond Mine is located at the north end of Contwoyto Lake, NU, approximately 200 km southeast of Kugluktuk, 200 km southwest of Bathurst Inlet and 420 km northeast of Yellowknife, NWT. The Original Licence was approved by the Minister of Indian and Northern Affairs Canada on January 25, 2005. The Original Licence was issued for a period of approximately six years, and will expire on December 31, 2010.

Construction of the mine began in March 2005 and the first production of rough diamonds began during the first quarter of 2006. Commercial production was achieved at the mine on July 1, 2006, with the official mine opening occurring on August 17, 2006. From July 1, 2006 until the mine went into receivership in late 2008, the mine produced more than 780,000 carats of gemquality diamonds from 1.2 million tonnes of kimberlite. The mine has not been operating since 2008 and is currently in care and maintenance.

On June 9, 2009, the Licensee applied to assign the Type A Water Licence (now renumbered) 2AM-JER0410 (the Existing Licence) from the Licensee to a new entity, Benachee Resources Inc. (no longer a wholly owned subsidiary of Tahera Diamond Corporation). On July 31, 2009, the NWB authorized the assignment of the water licence to the new licensee, Benachee Resources Inc. The assignment required the submission of numerous outstanding requirements of the Licence including:

- outstanding water use fees;
- 2008 annual report;
- as-built drawings;
- updates of the Spill Contingency Plan and General Monitoring Plan;
- an updated estimate of the total mine closure restoration liability; and
- confirmation that security in the amount of \$2.2 million was furnished.

On July 27, 2010, during court proceedings in relation to the Tahera receivership (Court File No. 08-CL-7355), the Ontario Superior Court of Justice approved the sale of Tahera's assets including the Jericho Diamond Mine to Shear Minerals Ltd. In addition, the order of the Honourable Justice Morawitz directed the Water Board to consider the application for assignment of the Existing Licence "forthwith". After a period of due diligence, the purchase by Shear Minerals Ltd. was completed at the end of August, 2010.

The Application:

On November 15, 2010 the NWB received an assignment request and associated documents from Shear Minerals Ltd. seeking to assign Licence 2AM-JER0410 from Benachee Resources Inc. to Shear Diamonds (Nunavut) Corp., a wholly owned subsidiary of Shear Minerals Ltd. In addition, given concern that the Existing Licence would be expiring on December 31, 2010, before Shear Diamonds (Nunavut) Corp. would be in a position to submit a full renewal

application, Shear Minerals Ltd. also sought a short-term renewal of the Existing Licence for a period of sixty (60) days commencing on January 1, 2011.

On November 17, 2010, mindful of the Court's order in July, 2010 and the upcoming expiry of the Existing Licence, the NWB determined that the current circumstances of this application constituted "urgent circumstances" pursuant to subsection 55(4) of the NWNSRTA. As a result, the Board's decisions in respect of the application, both the assignment and the short term renewal of the licence by a period of up to sixty days without a hearing, were subject to a shortened notice period (reduced from the usual thirty day minimum time period for public comment to a ten day minimum time period).

Accordingly, the parties were invited to provide comments to the NWB on or before 3:00 pm MST, November 29, 2010. The responses are summarized in Table 1 that follows.

⁴ Subsection 55(4) of the NWNSRTA states:

⁵⁵⁽⁴⁾ Where a public hearing is not held in relation to an application, the Board shall not act on the application until at least thirty days notice of the application that has been published under subsection (1) unless, in the opinion of the Board, there are urgent circumstances that justify the Board acting on that application in a shorter period, but that shorter period shall not be less than ten days.

Reasons for Decision

On November 30, 2010, the NWB Type "A" Panel considered the application and is satisfied that the assignment of the existing licence to Shear Diamonds (Nunavut) Corp. and the operation of the appurtenant undertaking by Shear Diamonds (Nunavut) Corp. would not be likely to result in a contravention of any condition of the licence or any provision of the *Act* or *Regulations*. Further, the NWB notes the confirmation from KIA that water compensation issues have been appropriately addressed by Shear Diamonds (Nunavut) Corp. and confirmation from INAC that the required security has been posted.

With respect to the issuance of a short-term renewal of sixty days from January 1, 2011, the NWB recognizes that there is insufficient time to provide a complete renewal application to the Board for review prior to the expiry of the Existing Licence. For the regulatory process to function effectively, it is in the best interests of all the parties for the NWB to receive applications that are thorough and complete. Consequently, the Board has decided to issue the short term sixty day renewal of the Existing Licence, with the expectation that Shear Diamonds (Nunavut) Corp. will submit their complete renewal application as soon as possible.

Reflecting these decisions, the Board requests the following from the Minister:

- acknowledgement of the assignment of Licence 2AM-JER0410 from Benachee Resources Inc. to Shear Diamonds (Nunavut) Corp. (a wholly owned subsidiary of Shear Minerals Ltd.);
- consent to the NWB's exercise of its jurisdiction to exempt the application for the short-term renewal from the requirement to hold a public hearing; and
- approval of the issued short-term renewal of licence 2AM-JER0410, with no changes to the conditions of that licence, for a period of sixty days (term commencing on January 1, 2011 and expiring on March 1, 2011).
