Recently, the Nunavut Impact Review Board (NIRB or Board) facilitated public scoping meetings in the Kivalliq Region from April 25<sup>th</sup> to May 10<sup>th</sup>, 2010, as part of the NIRB's review of the AREVA Resources Canada Inc's "Kiggavik" project proposal. Communities that were visited included Baker Lake, Repulse Bay, Coral Harbour, Chesterfield Inlet, Arviat, Whale Cove and Rankin Inlet. The enclosed report titled *Public Scoping Meetings Summary Report*, *April 25 – May 10, 2010 for the NIRB's Review of AREVA Resources Canada Inc's Kiggavik Project* has resulted from the discussions that were held during these meetings and provides a summary of the comments and concerns that were raised in the communities visited.
