Notice is given that the Nunavut Impact Review Board (NIRB) will be holding the Final Public Hearing in respect of the NIRB’s Review under Part 5 of Article 12 of the Nunavut Land Claims Agreement of the ecosystemic and socio-economic impacts of the Kiggavik Uranium Mine project proposal (NIRB File No. 09MN003) submitted by AREVA Resources Inc. (the Proponent).

Procedure:

The Final Hearing and the form and content of written submissions will be guided by the *NIRB Rules of Procedure*, the NIRB’s Pre-Hearing Conference Decision issued July 5, 2013, and any project-specific guidance provided by the Board. All proceedings will be open to the public and media, and will be conducted with simultaneous English-Inuktitut interpretation and, upon request, English-French interpretation. Media who wish to attend the Final Hearing are asked to advise the Board in advance.

Participation:

Parties wishing to participate as formal intervenors must submit a completed Intervenor Application (available from the NIRB) by December 5, 2014. Successful applicants for intervenor status and members of the public wishing to provide written comments to be considered at the Final Hearing must file their comments with the NIRB by January 16, 2015. Even if you have not provided written comments, at the Final Hearing any person who wishes to express their views may register with the Board on the day of the Hearing to share their spoken comments and questions during the portions of the Hearing set aside to hear the views of the public.

- December 12, 2014:** NIRB to announce determination with respect to applications for intervenor status applications
- January 16, 2015:** Deadline for final written submissions (5:00 p.m. MT)

- March 2-20, 2015:** Final Hearing, Baker Lake, NU
