Hello Aaron,

didn't hear anything back at 4pm last night, so I thought I would try again with email. Essentially for the emergency discharge, if you could evidence with surveys, photographs and water quality data showing compliance with effluent quality. Justification for release might include any risk that the facility would be in, if discharge does not occur. You could also provide background that the discharge was planned to take place with a renewal licence issued and that the application had been provided and is currently before the Board. That treatment of the water was undertaken in anticipation of discharge etc. I am unsure as to the timeline for something like this to go to the minister, given some of the news from the Feds this last week.

Aaron,

I meant to get you an email yesterday but that didn't happen. Rushing today and thought I'd better check in with you on the Status of Lupin.

I checked with our legal counsel and Dionne (Exec Dir) on Tuesday after they had a chance to review some of the information I provided. I had pointed out a few items with the Licence and that the Act specifically states that there can be NO deposit of waste without a licence. An interpretation prior led us to believe that "obligations" under the licence would include discharge, however that is not the case. In order to discharge, the BOard would be required to submit a request to the Minister for an emergency discharge without a licence. This would require the Company to document and evidence that without the discharge the facilities would be at

risk, and, that the discharge would be in compliance with all licence parameters as issued in 2000.

I will be out of the office for part of the afternoon, however if you need to discuss further, I should be back in about 4pm and we might be able to get Dionne on the phone as well.
