- 1) **NWB1LUP008**-In compliance with their water license for the Lupin Mine, Echo Bay Mines submitted;
 - a) The Interim Abandonment and Restoration Plan and The Cost Estimate for Lupin Mines Site Reclamation, for which submissions will be considered as a part of the proponent's current proposal to amend their water license.
 - b) The Contingency Plan
 - c) The Tailings Containment Area Management Report
 - d) Geotechnical Inspection
 - e) 2000 Annual Report/Bioassay Test/2000 Thermistor Installation Report

Comments of these plans and the amendment request associated with Lupin mine are due on July 24, 2001.

- 2) **NWB1NAN9702** In compliance with their water license, Nanisivik mine submitted;
 - a) The Hydraulic Confinement of the West Twin Disposal Area, for which the NWB approved the terms of reference for the study in 1998. The two years of sampling data concludes that there is "no evidence supporting a subterranean hydraulic connection between West and East Twin Lakes."
 - b) Phase II Environmental Site Assessment, for which follow-up data collection may needed this summer depending on the outcome of the technical review.

- c) Waste Rock Disposal Plan for 2001
- d) Long Term Tailings Disposal Plan 2001
- e) The Metal Loading Study, in which results are given of three years of monitoring in Twin Lakes Creek.
- f) Revised Interim Closure (Abandonment) and Restoration Plan. In a letter dated September 14, 1999, the NWB provided comments to Nanisivik following the technical review of the 1998 plan. Upon receipt of technical comments, finalization of the plan will occur.
- g) Test Cell Evaluation Report
- h) 2000 Annual Water Report.

Comments on the any of the plans associated with Nanisivik mine are due on July 31st, 2001

3) **NWB1ULU0008**- In compliance with their water license, Echo Bay Mines submitted the Interim Abandonment and Restoration Plan for the Ulu Project. **Comments are due on August 10, 2001.**
