**Re: Licence 2AM-LUP0914, Type “A”; Renewal Application - Rescheduling of TM/PHC and Extension to Technical Review Period**

Dear Mr. Downey:

On August 14, 2014, the Nunavut Water Board (the NWB or the Board) issued correspondence<sup>1</sup> regarding the Type “A” water licence renewal application for Lupin Mines Incorporated’s (LMI or the Licensee) Water Licence No. 2AM-LUP0914, informing interested persons that, for the purpose of minimize potential scheduling conflicts for prospective participants, the Board was contemplating rescheduling the in-person, Technical Meeting/Pre-Hearing Conference (TM/PHC) originally scheduled for the first week of September and extend the technical review and comment deadline period. Further, the NWB indicated in the aforementioned correspondence, that following the Board Panel’s consideration and decision, the NWB will release details pertaining to the rescheduled date(s) for the TM/PHC and associated filing timelines.

On August 19, 2014, the Board Panel convened and following the required deliberations, decided on suitable date(s) for rescheduling the TM/PHC. By copy of this email, interested persons are informed that the TM/PHC for the renewal of Licence 2AM-LUP0914 has been rescheduled to be held on **October 22-23, 2014**, in the community of Kugluktuk. Accordingly, the Board has also extended the technical review comment period to **September 19, 2014**. The NWB would
