Melissa: A quick update on progress at Lupin. We took a full round of samples from the pond and the SNP sites on Sunday afternoon and Monday morning. They were sent to ALS in Edmonton around noon on Monday. We expect preliminary test results to be coming out in the next several days. The definitive test will be the toxicity bioassay tests, which should be available Friday or Monday. The field pH was 8.04 when the samples were taken; therefore I would expect compliant results.

Will you be in your office or travelling either Friday or Monday when the test results come in. If you are travelling is there a way that I could reach you over the phone to convey the results and get an OK to start releasing water. Time is a bit of the essence since it took extra lime and time this year to get the pond to come up to release status.
