Dear Mr. Pedersen:

Please be advised that we plan to commence discharge from Pond 2 in approximately 10 days, on or about August 27, 2018. We plan to discharge approximately 4 million cubic meters into the receiving environment.

We are currently liming the Pond 2 and monitoring the pH. When the pH meets the range of 6 to 9.5, discharge may commence. Because the weather may become an issue, we may request approval from your office to commence discharge sooner than August 27, 2018 with the pH meeting the Water Licence criteria.

Below find Table 1, which contains the water quality lab results for parameters specified in the water licence, and Table 2 contains the Trout 24 hour and the Daphnia 48 hour Acute Toxicity Bioassay for samples collected August 09th.
