RE: Type “A” Licence No. 2AM-LUP1520 – Request to Modify Part G, Item 4 of the Licence

Dear Ms. Lewis:

The Nunavut Water Board (NWB or Board) received from Lupin Mine Incorporated (“LMI” or the “Licensee”), on June 7, 2016, a formal, written request to modify aspects of the requirements pertaining to Part G, Item 4 of Type “A” Water Licence No. 2AM-LUP1520, which states as follows: “The Licensee shall submit to the Board for review, at least sixty (60) days prior to construction of a proposed Landfarm Facility, for-construction design drawings and specifications, signed and stamped by an Engineer.”

LMI’s modification requests specifically centres on the requirement for submission of for-construction drawings at least sixty (60) days prior to commencing construction of the Landfarm Facility authorized under Part E, Item 21 in the Licence. While the Licensee has submitted the relevant drawings and associated documents for the facility as required under Part G, Item 4 in the Licence, it is requesting that the minimum sixty (60) day period mentioned above be relaxed to enable it to construct the facility in a timely manner, during this year’s on-site activities.

The NWB, having reviewed the information included as part of the Licensee’s requests in the context of the relevant terms and conditions in the Licence, determined that the Licensee may commence construction of the facility within the sixty day (60) period following the date of submission of the required drawings and documents as constructing the facility earlier rather than later does not fundamentally alter the intent of Part G, Item 4 of the Licence. The Board has granted the Licensee’s request under Motion No. 2016-A1-001.

The Licensee is reminded, however, that consistent with the terms and conditions under Part G, Item 3 in Licence No. 2AM-LUP1520, a construction summary report, including as-built drawing of the facility, signed and stamped by an engineer, must be submitted the Board for review within ninety (90) days following completion of construction of Landfarm facility.
