Discharge from the No.2 Sewage Lake via syphon continued through to August 17, 2001 at which point it was shut down for repairs to the culvert. A series of samples were obtained along the shoreline following the repair to the culvert. The pH of the samples were determined to be less than 6.0 at all locations and no further discharge was planned.

A sample was obtained on August 13, 2001 and submitted to Norwest Labs. Ltd. in Edmonton for analysis. The results are included in the attached report.
