This Licence incorporates two previously issued Type B licences, 8BC-TEH0809 for the All Weather Private Access Road and 8BC-MEA0709 for the Baker Lake Marshalling Facility. To the extent that any reports, studies and plans pursuant to the Type B licences are not yet received or approved by the Board, the requirement(s) becomes part of this Licence.

As a result the NWB cancelled 8BC-MEA0709 by way of motion number 2008-04-20 & 8BC-TEH0809 by way of motion number 2008-04-18.
