How are you?

It seems we didn't still receive NIRB confirmation (likely Exemption) with respect to the Meadowbank Gold Project 2AM-MEA0815 Licence straight renewal application.

You may be aware the AEM also applied pursuant to s. 9 of Waters Regulations for up to 180 days Short Term Renewal (STR) of their Licence to minimize the risk of being in the situation when the Licence is not renewed prior to the expiry date of May 31, 2015.

As the NWB's intention is to process this STR application as quick as possible once the comment period is closed in March 9th the NWB would like to have NIRB advise regarding the Renewal Application.
