On July 30, 2015 the Nunavut Impact Review Board (NIRB or Board) initiated the public technical review period for Agnico Eagle Mines Ltd.'s (AEM or Proponent) proposed Vault Pit Expansion to the Meadowbank Gold Mine Project (NIRB File No. 03MN107). Following the receipt of AEM's response to the Information Requests on October 1, 2015 the NIRB invited interested parties to provide the Board with their technical review comments regarding the Addendum to the Final Environmental Impact Statement for the Vault Pit Expansion proposal by December 4, 2015.

On or before December 8, 2015 the NIRB received technical review comment submissions from the following parties:
