As previously announced, the Nunavut Impact Review Board (NIRB or Board) has scheduled a Technical Meeting via teleconference to enable discussion with respect to Agnico Eagle Mines Ltd.'s (Agnico Eagle or Proponent) proposed "In-Pit Tailings Disposal Modification" project (NIRB File No.: 03MN107).

The Technical Meeting is to facilitate discussion amongst the Proponent, the NIRB staff, and Regulatory Authorities to assist in determining whether the proposed changes warrant reconsideration of the existing terms and conditions of Project Certificate No. 004 or whether the project amendment could proceed with updates to the requirements of the existing monitoring program for the Meadowbank Gold Mine.
