Dear Parties,

In consideration of the attached correspondence received by the Nunavut Impact Review Board (NIRB or Board) from Agnico Eagle Mines Limited (Agnico Eagle) and from the Northern Projects Management Office regarding Agnico Eagle's "In-Pit Tailings Disposal Proposal", the Board is extending the timeline for the submission of Information Requests for this assessment to July 3, 2018. While this timeline extension will necessarily require a revision to the deadline for the Proponent's response to final written submissions to be required, the Board expects that the remaining timelines can continue to be met, as previously communicated:

- July 3, 2018: Intervenors file Information Requests
- July 10, 2018: Agnico Eagle provides responses to Information Requests
- August 1, 2018: Intervenors file final written submissions
- August 15, 2018: Agnico Eagle files a final reply to written submissions
- August 31, 2018: NIRB issues a Reconsideration Report and Recommendations under s. 112(5) of the NuPPAA
