## Dear Jamie Quesnel:

On June 18, 2018 the Nunavut Impact Review Board (NIRB or Board) provided a Notice of Reconsideration of the terms and conditions of Project Certificate No. 004 under Section 12.8.2 of the Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement) and under s. 112 of Nunavut Planning and Project Assessment Act for Agnico Eagle Mines Limited's (Agnico Eagle, or Proponent) proposed "In-Pit Tailings Disposal Modification" project (the In-Pit Tailings Disposal Proposal)<sup>1</sup>. The Board requested that interested parties submit Information Requests (IR) to facilitate their technical review of the In-Pit Tailings Disposal Proposal by June 26, 2018<sup>2</sup>, with a response to the IRs received from Agnico Eagle on July 11, 2018 and July 16, 2018.<sup>3</sup> Following receipt of the responses to IRs from Agnico Eagle, the NIRB reminded parties to file final written submissions by August 1, 2018 to facilitate the review of the In-Pit Tailings Disposal Proposal.
